2. Subject of the procurement:

Electricity for the period **March 1, 2012 – December 31, 2014.**

3. Content of the Bid

In order to meet the requirement for signing of the Framework Agreement, the Bidder shall be obliged to deliver the following qualification documents:

- 3.1.** Evidence that the Bidder has neither been convicted for offences nor pronounced the measure of prohibition to perform the activity which is subject of the procurement;
- 3.2.** Extract from the court, professional or commercial register of the state which is the seat of a bidder or valid permit, i.e. licence of a competent authority for professional performance of the activity;
- 3.3** Evidence that a legal entity is not in bankruptcy or liquidation procedure – certificate of the court, i.e. competent authority from the state of seat;
- 3.4.** Evidence from the administrative authority competent for taxes and organization of the pension and health insurance that the obligation for payment of taxes and contributions is fulfilled;
- 3.5.** Evidence that payments to the bidder are not suspended – appropriate bank statements, certificate or statement about financial suitability of the bank whose client is a legal entity;
- 3.6.** Report on accounting and financial situation – income statement and balance sheet, i.e. report of the licenced auditor in cases it is prescribed by the Law on accounting and audit for the last two years, i.e. for the period after registration if a company is registered later;

3.7. Bidder's references – evidence about professional, technical and personnel suitability.

All the Bidders with whom the Framework agreement was concluded according to Invitations No. 27/10, 27-03/10 and 83/11 will be obliged to submit only the documents under No. 3.5. and No. 3.6.

4. Bids are to be submitted in the official language spoken in Montenegro.

7. Bid Opening Procedure

Opening of the bids shall be held after expiry of the final deadline for submission of bids, January 26th, 2012 (Thursday), by 12:30 p.m. in the premises of EPCG AD Nikšić, Company's Head Office, 2 Vuka Karadžića Street, Nikšić.

Incomplete, non-sealed and bids received beyond aforementioned deadline will not be taken into consideration.

Representatives of the Bidder who will attend the tender opening procedure will be obliged to enclose signed and verified authorization that they may attend the opening procedure.

8. Signing of the Framework Agreement

EPCG AD Nikšić shall sign the Framework agreement with all the Bidders who provide the complete »TENDER DOCUMENTS«.

EPCG AD Nikšić shall sign Annex to the existing Framework agreement with all the bidders with whom the Framework agreement has been previously signed and who submit the requested documents.

9. Deadline for making the decision about contract award

All the bidders will be informed about results of the bidding not later than by February 16, 2012.
